She said the additional units to the UC Terrace East condo project at Governor Dr. and Genesee Avenue were approved by the UC Planning Group. Meanwhile, she said the Regents Road apartment complex, just south of Our Mother of Confidence Roman Catholic Church, was denied by UCPG.

**Beautification: (Merle Langton):** Merle said that we are waiting for Sheri Carr from Sheri Lightner's office to see if the City will remove the concrete and the asphalt at no expense to the UCCA. I might also have said that we had contacted the Urban Corps and are expecting a quote by March 5<sup>th</sup>.
